## 人体皮肤斑贴测试

### 测试方法:

化妆品安全技术规范 2015

受试物: 原样

阴性对照: 空白

受试者: 共 30 人, 男 6 人, 女 24 人, 年龄 21-56 岁, 平均年龄  $33 \pm 9.0$  岁, 100% 敏感性肌肤, 符合受试者志愿入选标准

测试方法: 选择面积不超过  $50\text{mm}^2$ , 深度约为 1mm 的合适斑试器, 以封闭式斑贴试验方法, 将受试物约  $0.020 \sim 0.025\text{g}$  (mL) 加于斑试器内。将斑试器贴敷于受试者背部, 24 小时后去除受试物, 分别于去除后 0.5、24、48 小时观察皮肤反应, 按《化妆品安全技术规范 2015》中皮肤反应分级标准记录其结果。

### 测试结果:

人体皮肤斑贴实验结果显示, 在移除后 0.5h、24h 和 48h 这 3 个观察时间点, 30 名受试者皮肤反应均为阴性反应。
